FIREWORKS PERMIT

INSTRUCTIONS

1. **Complete all information on Page 1 and Submit the completed application to**

2. **You are required to have a permit prior to the purchase, possession of use of fireworks in the town of Two Creeks.** Fireworks can be purchased anywhere in this state and the possession of the fireworks is allowed under this permit while the permit holder is transporting the permitted fireworks to the Town of Two Creeks (the town where the possession and use is authorized by this permit). However, the permit holder must take the most reasonable direct route between the location of purchase and the location of the permitted use of fireworks indicated on this permit. Remaining in a non-permitted city, village or town for more than 12 hours means you are no longer "transporting" the permitted fireworks.

3. **Special Conditions:**
 - ☐ To protect the public health and safety, a permit may be denied or cancelled during periods of high fire danger.

 - ☐ The person issuing this permit may require an indemnity bond with good and sufficient sureties or policy of liability insurance for the payment of all claims that may arise by reason of injuries to person or property from the handling, use or discharge of fireworks under the permit. The bond or policy, if required, shall be taken in the name of the Town of Two Creeks, and any person injured thereby may bring an action on the bond or policy in the person's own name to recover the damage the person has sustained, but the aggregate liability of the surety or insurer to all persons shall not exceed the amount of the bond or policy. The bond or policy, if required, together with a copy of the permit shall be filed in the office of the Town Clerk.

 - ☐ A copy of this permit shall be sent to the Manitowoc County Sheriff's Department, The Wisconsin DNR and the Two Creeks Volunteer Fire Department, at least 2 days prior to the date of authorized use of the listed fireworks

 - ☐ A permit shall not be issued to a minor under age 18.

 - ☐ The Town and its officials and employees shall not be civilly liable for damage to any person or property caused by fireworks for the sole reason that the Town issued a permit in accordance with the requirements of § 167.10(3), Wis. Stats., and any applicable requirements authorized under § 167.10 (5), that authorized the purchase, possession, or use of the fireworks.

 - ☐ The permittee is responsible for compliance with the fireworks law, §167.10, Wis. Stats.

 - ☐ The Town of Two Creeks reserves the right to assign police and fire protection personnel to the fireworks event for the purpose of fireworks law enforcement and fire suppression. However, the Town of Two Creeks shall be indemnified by the permittee for any personal injury or property damage related to the official acts of town representatives.

 - ☐ **LITTERING WATERS PROHIBITED.** No person shall deposit, place or throw from any boat, raft, pier, platform or similar structure any cans, papers, bottles, debris, refuse, garbage, solid or liquid waste into the waters of any lakes within the jurisdiction of the Town of Two Creeks.
